

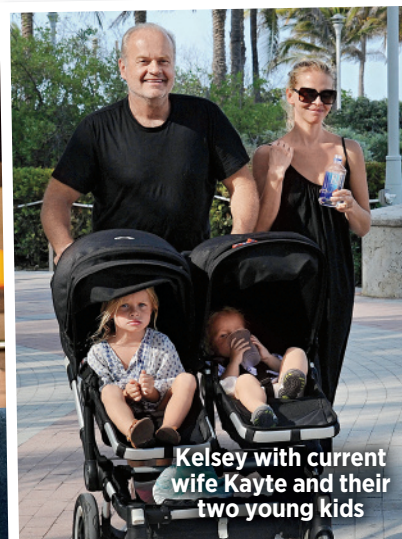


# GRAMMER ABUSED WIFE CAMILLE!

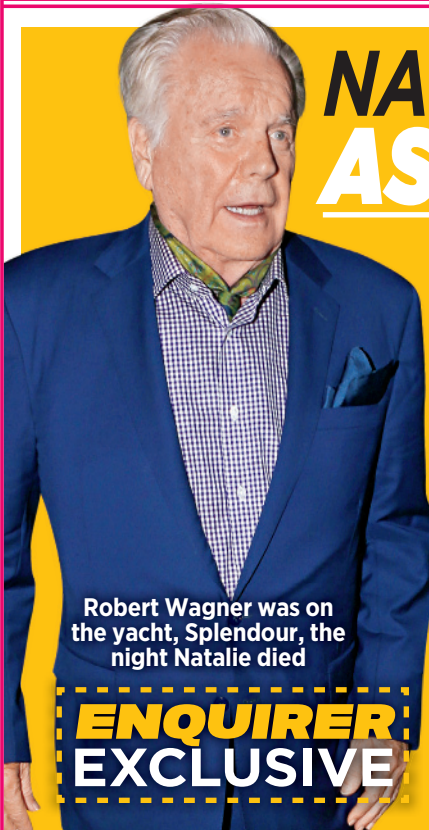

**K**ELSEY Grammer — star of “Frasier” — hid a shocking secret side from his fans ... the beloved TV shrink abused ex-wife Camille! Court documents have revealed the blond bombshell claimed Kelsey battered her verbally during an ugly custody battle over their two children. Camille, 47, also said

the former “Cheers” star “grabbed her arm or injured her shoulder” earlier in their marriage, a source dished. The explosive allegation of verbal abuse came out during Camille’s legal battle with a former boyfriend. In a deposition, her psychiatrist, Dr. Bethany Tucker, read from notes taken during a session with Camille

on Jan. 6, 2012. The notes read: “Patient realizing the abuse she took from Kelsey and how it affected her. “She was dealing with the custody battle with the kids. So sometimes — she felt she had ... some verbal abuse.” Dr. Tucker added: “Patient concerned about lies Kelsey is saying about her.”

Kelsey and Camille were married on Aug. 2, 1997, and had children Mason, 14, and Jude, 11. Camille filed for divorce in July 2010 after learning Kelsey had impregnated flight attendant Kayte Walsh. A rep for 61-year-old Kelsey strenuously denied he physically or mentally abused Camille.

## NATALIE WOOD PROBE STALLS AS COPS REFUSE TO TALK!

**THE** crusade to find the truth about Natalie Wood’s mysterious death has stalled yet again — as key investigators clammed up about the case! Almost 35 years after her suspicious drowning, attorney Sam Perroni filed legal documents to compel cops to expose bombshell evidence that he believes will prove the screen siren’s husband, actor Robert Wagner, murdered her. But not only did investigators refuse to answer many of his

questions, one of them didn’t even show up! “L.A. chief of detectives William McSweeney was under subpoena, but willfully failed to appear to testify,” Sam, a former federal prosecutor in Little Rock, Ark., told The National ENQUIRER. Three others, including Lt. John Corina of the L.A. County Sheriff’s homicide division, an L.A. detective and a former investigator for the L.A. County Medical Examiner’s office, sat for hour-long depositions.

But their statements were “just more cover-up and obstruction of the truth,” Sam told The ENQUIRER. “It was like they were taking the Fifth (Amendment to avoid incriminating themselves) on all crucial points relating to whether Natalie’s death was a homicide, and whether Wagner was a suspect. “But at some point, they will have to show their hand, and then the public will know the truth!” **NE**
